NOTIFICATION

MAHARASHTRA PROTECTION OF INTEREST OF DEPOSITORS (IN FINANCIAL ESTABLISHMENT) ACT, 1999.

No. MPI-1118/C.R.1228/POL-11.—Whereas, complaints have been received from number of depositors against **Pan Card Club Pvt. Ltd.** (hereinafter referred to as "the said Financial Establishments"), complaining that they have collected the Fund and have defaulted to return the said deposits made by the depositors, on demand;

And whereas, an offence has been registered against the accused at E.O.W. Mumbai vide C.R. No.98/2017, u/s, 406, 420,34 of Indian Penal Code r/w 3 and 4 of Maharashtra Protection of Interest of Depositors (in Financial Establishments) Act, 1999;

And whereas, the State Government is satisfied that the said Financial Establishments and their Chairmen/Directors are not likely to return the deposits to the depositors and hence the Government has to protect the interests of the depositors;

And whereas, the properties specified in the Schedule appended hereto are alleged to have been acquired by the said Financial Establishments and their Chairmen/Directors from and out of the deposits collected by the said Financial Establishments;

Now, therefore, in exercise of the powers conferred by sub-section(1) of section 4, section 5 and section 8 of the Maharashtra Protection of Interest of Depositors (in Financial Establishments) Act, 1999 (Mah. XVI of 2000) (hereinafter referred to as "the said Act"), the Government of Maharashtra hereby,—

(a) attaches the properties of the said Financial Establishments and the property in the name of their Chairmen/Directors as specified in the Schedule; and

(b) appoints the Deputy Collector, (M.P.I.D.), Mumbai City, Fort, Mumbai to be the Competent Authority to exercise control over the properties attached of the Financial Establishment and its Directors;

The Public Prosecutor in designated court appointed under the said Act shall render necessary assistance to the Competent Authority in filing the application before the Special Court.
